

6 Remarks

Period of Validity

The scope of accreditation is listed on www.oeti.biz. Due to the system for the mutual recognition of national accreditations (ILAC/IAF), this accreditation is valid worldwide.

Statements of conformity are based on the specifications of the specified standard. The "simple acceptance rule" applies, that means the measurement uncertainty is stated for the statement of conformity, but not taken into account.

In this report individual non-accredited test procedures are marked with *. However, the analysis was also carried out for these parameters at the same level of quality as for the accredited parameters.

According to the decree on the use of the accreditation mark ("AkkZV") the accredited Conformity Assessment Body is the only one to use the accreditation mark. Application of the registration number of the Notified Body: As to personal protective equipment (PPE) the requirements of Regulation (EU) 2016/425 have to be kept.
